

5. All bids shall be accompanied by a valid bid security issued by "A" class commercial bank of an amount as shown in the table above. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hrs on 2075/21/09(5th Jan, 2019) At the Chhipaharmai rural Municipality Office, Parsa. Bids must be valid for a period of 45 days i.e. 2075/11/06(18th Feb 2019) after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid i.e. 2075/12/06(20th Mar. 2019)
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
